NOTICE IS HEREBY GIVEN That Clearwater County will be conducting a Consolidated Election on Tuesday, May 21, 2019, for the following taxing districts and for the following purposes, to be held at precinct locations all as indicated below. Identification is required and voter must be a US citizen, at least 18 years of age, who has resided in the county and taxing district for at least thirty days prior to election. Voter must re-register if any changes in name or address have occurred since the last election.

NOTICE OF SUPPLEMENTAL LEVY ELECTIONS
