Individuals who run as write-in candidates must file a declaration of intent no later than 5:00 p.m. on September 20, 2019. The last day a candidate may withdraw before the November 5 election is also September 20, 2019.

The clerk of the political subdivision must certify any nominees and special question placed by action of the governing board of the subdivision to the County Clerk by September 13, 2019.

September 16, 2019 is the last day for the clerk of the political subdivision to certify the wording to the County Clerk for a bond, levy initiative, referendum, recall or any the ballot question ordered for the November 5<sup>th</sup> election. At this time we have not received any notifications of any special elections. Taxing districts must notify County Clerk of any special elections to be held by the dates referred to above.
